Important note: When a CMP (80053QW) is run with a Lipid panel (80061QW) on the same patient in the same day, CMS will bundle the two tests as an ATP 16 plus HDL (83718QW). For 2016, the bundled national average reimbursement is \$25.55.

The above chart represents the CMS published national average reimbursement for each panel configuration. Actual reimbursement amounts vary depending upon the state and region. This chart does not represent any private payor or medicaid reimbursement. It is important to check with your contracted payors to determine your test reimbursement based upon your individually negotiated contract.

Test reimbursement is used to supplement the overall financial impact of point-of-care diagnostics in the practice. It is important to consider all factors of practice improvement when determining return on investment.
